ORDINANCE NO. 2023-009

AN ORDINANCE CREATING A LOCAL HEALTH BOARD IN THE MUNICIPALITY OF CAINTA, CONFIRMING ITS COMPOSITION FOR THE YEAR 2023-2025, DEFINING ITS DUTIES AND RESPONSIBILITIES AND FOR OTHER PURPOSES

WHEREAS, one of the policies of the State as enumerated under Article I of the 1987 Philippine Constitution is that the State shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, Article XIII, Section 11 of the 1987 Philippine Constitution also states that the State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all the people at affordable cost and there shall be priority for the needs of the underprivileged sick, elderly, disabled, women, and children;

WHEREAS, Section 102 of Republic Act No. 7160 otherwise known as the Local Government Code of the Philippines states that a Local Health Board should be established in every province, city or municipality;

NOW THEREFORE, BE IT ORDAINED AS IT IS HEREBY ORDAINED BY THE SANGGUNIANG BAYAN IN A SESSION DULY ASSEMBLED THAT:

Section 1. Creation. The Local Health Board in the Municipality of Cainta is hereby created.

Section 2. Composition. The membership of the Local Health Board is hereby reconstituted as follows:

Chairperson : Hon. Elenita D. Nieto, Local Chief Executive

Co-Chairperson : Hon. Sitti Ruaina Ferriols, SB Committee Chair on Health

Vice Chairman : Dr. Edgardo Gonzaga, Municipal Health Officer

Member : Dr. Anna Amado-Sohaco, Rep, DOH-CALABARZON

Section 3. Duties and Responsibilities

- a. Propose to the Sangguniang Bayan concerned, in accordance with standards and criteria set by the Department of Health, annual budgetary allocations for the operation and maintenance of health facilities and services within the municipality;
- To serve as an Advisory Committee to the Sanggunian concerned on health matters, such as, but not limited to, the necessity for, and application of, local appropriations for public health purposes;
- c. Consistent with the technical and administrative standards of the Department of Health, shall advise and coordinate with local offices such as Human Resources on matters such as, but not limited to personnel selection and promotion, grievance and complaints, personnel discipline; Budget office for health budget review; General Service Office on logistics and supplies needed and necessary to maintain the day to day health operations of various health care facilities, units and special clinics and similar functions operating within the municipality;
- d. Set overall health policy directions and strategic thrusts including the development and implementation of the integrated strategic priorities pertaining to health and development of annual investment plans of the municipal health system;
- e. Oversee and coordinate the integration and delivery of health services across the health care continuum for municipal-wide health system;

Section 4. Secretariat. The Local Health Board shall have a Secretariat which shall be the Municipal Health Office which task is to handle all administrative related activities. It shall ensure all meetings of the Board are effectively organized and recorded;

Section 5. Meetings. The Local Health Board shall meet at least once a month or as often as may be deemed necessary. Record of said meeting shall be kept by the Secretariat.

Section 6. Operational Expenses and Funding. All expenses necessary and incidental to the effective operation of the Board shall be charged against the Municipal Health Office.

Section 7. Effectivity. This Ordinance shall take effect upon its approval.
