ORDINANCE NO. 2022-002

AN ORDINANCE AMENDING THE ANTI-LITTERING ORDINANCE (ORDINANCE NO. 2000-09) AS AMENDED BY ORDINANCE NO. 2008-010 – PROHIBITING SPITTING, URINATING, DEFACATING AND/OR LITTERING OF PAPER AND OTHER RUBBISH IN PUBLIC BUILDINGS, STREETS, PLAZAS AND OTHER PUBLIC PLACES IN CAINTA, RIZAL, AND PROVIDING PENALTIES FOR VIOLATION THEREOF

WHEREAS, the One Cainta Administration aims to focus its thrust in preserving the environment;

BE IT ORDAINED AS ITS IS HEREBY ORDAINED BY THE SANGGUNIANG BAYAN OF CAINTA IN A SESSION DULY ASSEMBLED THAT:

Section 1. Title. This Ordinance shall be known as the **One Cainta Environmental Protection Ordinance**.

Section 2. Prohibited Act/s. It shall be unlawful for any person to spit, urinate, litter, to dump, place throw or scatter waste refuse, garbage material, papers, cigarette butts, non-biodegradable objects and other waste materials in any public facilities such as but not limited to buildings, streets, parks, plazas and other public places not designated as dumping place.

It is likewise unlawful to throw waste refuse, garbage material, papers, cigarette butts, non-biodegradable objects, dead animals and other waste materials in bodies of water and waterways, such as but not limited to rivers, creeks, streams, esteros and canal.

Section 3. Every household and business establishments is hereby required to provide trash cans/containers or any receptacle for garbage disposal and shall be placed in front of the house or building or at the inner side of the sidewalk during the designated time for garbage collection.

Section 4. Implementing Arm. The following offices are hereby tasked to enforce this Ordinance:

- a. Municipal Public Safety Office (MPSO)
- b. Road Clearing
- c. Night Watch
- d. Municipal Environment and Natural Resources Office (MENRO)

Section 5. Penal Clause. Any person or establishment found to be in violation of this Ordinance shall be penalized as follows:

1st Offense	Php 1,000.00 Fine
2nd Offense	1,500.00 Fine
3rd Offense	2,500.00 Fine

Section 6. Repealing Clause. Any Ordinance or local issuances inconsistent with the provisions of this Ordinance is hereby repealed accordingly.

Section 7. Separability Clause. If for any reason or reasons, any part or provision of this Ordinance shall be held unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.






Section 8. Effectivity. This Ordinance shall take effect immediately within fifteen (15) days upon its approval and publication in newspaper of local circulation.




